



OttLite One (1) Year Limited Warranty

OttLite Technologies, Inc. ("OttLite") warrants to the original purchaser that the surge protector shall be free of defects in material and workmanship for one (1) year from the date of original retail purchase (the "Warranty Period"). If a valid warranty claim is made to OttLite during the Warranty Period, OttLite, at its option, may repair the defective surge protector, replace the defective surge protector, or refund the original purchase price. OTTLITE WILL NOT BE RESPONSIBLE FOR ANY LOSS OR DAMAGE TO ANY DEVICE CONNECTED TO A SURGE PROTECTOR.

To obtain warranty service or a shipping address simply call 1-800-842-8848 or email custserv@OttLite.com. An OttLite customer service representative will assist you. If it is necessary to return the surge protector, OttLite's representative will provide you with a Return Authorization Number (RMA). In this event, please return the complete unit with proof of purchase. All cost to ship the surge protector to the designated location for inspection shall be borne solely by the purchaser. You are responsible for loss of or damage to a surge protector while it is in transit to the shipping address.

All surge protectors must be plugged directly into a properly wired AC power line with a protective ground and must not be "daisy-chained" together in serial fashion with other power strips, UPSes, other surge protectors, three-to-two-prong adapters, or extension cords. Any such installation voids this limited warranty. The surge protector may only be used indoors and in dry areas.
